

OFFICIAL CONTEST RULES FOR
Entercom Wichita, LLC (d/b/a KDGS FM, KEYN FM, KFBZ FM, KNSS AM, KFH AM/FM)
“Hannah Montana Look-a-Like Costume Contest”
Valid March 14th, 2008 through April 12th, 2008.

Who Can Enter

1. Contestants must be legal US citizens or residents and residents of the State of Kansas, who are 17 years of age or younger. All contestants will be required to have their parent/legal guardian co-execute all documents required in connection with this contest and failure to do so in a timely manner will result in automatic disqualification and any prize will be forfeited. For all purposes under these rules, the parent or legal guardian will be recognized as the actual winner of the prize.
2. Employees of Entercom Wichita, LLC d/b/a KDGS FM, KEYN FM, KFBZ FM, KNSS AM, KFH AM/FM (“Stations”), and their respective parents, subsidiaries, and affiliated companies, advertising and promotion agencies, and providers of any prizes in this contest ("Sponsors") and their immediate families and household members (i.e., spouses, parents, grandparents, children, grandchildren, co-habiting partners, roommates, and siblings) are NOT eligible to enter or win. Employees of any Wichita area radio station are NOT eligible to enter or win. (“Stations”) may require proof of age, identification, and/or social security number.
3. Persons who have won another contest or promotion of any kind from the station within the preceding thirty (30) days or prizes valued over \$600 within the immediately preceding six (6) months are NOT eligible to win in this Contest. Limit one winner per household (if multiple prizes are won, only the first prize won will be awarded). Limit one (1) qualifier per household.

How to Enter

1. No purchase necessary to enter or win.
2. Beginning on Wednesday, March 12, 2008 through Friday, April 4, 2008 between 9:00am (CST) on Monday and 5:00pm (CST), you may call 316-685-2121 and ask to be entered into the Saturday, April 12, 2008 Hannah Montana Look-a-Like Costume Contest held at the Fun Fair For Kids Expo event at Century II Expo Hall in Wichita, KS and provide all required information. There will be no on-air announcement to call at a particular time.
3. Stations will accept calls only between 9:00am and 5:00pm Monday through Friday. However, Stations are not obligated to always answer the telephone. In order to be entered, the entrant or his or her parent or legal guardian must speak to a Station representative who answers the telephone and provide the entrant’s name, address, phone number, age, and parent or legal guardian e-mail address.
4. Only calls received at the preceding phone number are eligible to participate in this contest.
5. Sponsors are not responsible for any technical difficulties experienced due to loss of phone service, electronic problems or any other factor that may prevent an individual from completing a phone call or for any technical malfunction related to any telephone connection or any other technical problem that may impact entry or prize claim including,

without limitation, any internet telephone call connections. Station is not responsible for disconnected, dropped, misdirected, lost or incomplete calls.

How to Win

1. All pre-registered entrants will receive two (2) tickets to the Event, one for the entrant and one for their parent/legal guardian.
2. Pre-registered entrants must be present at 12:00pm on Saturday, April 12, 2008 and complete check in at the Entercom Radio booth by 12:30pm at The Fun Fair For Kids Expo event at Century II Expo Hall in Wichita, KS. **The entrant and his/her parent or legal guardian must execute a liability release agreement and affidavit in order to participate in the final event. Failure to do so will result in automatic disqualification.**
3. Entrants must be escorted by no less than one of their parent/guardians at all times during the Event (as defined below).
4. Beginning at 1:00pm the afternoon of April 12, 2008, The Stations will conduct a Hannah Montana Look-a-like Contest from among all pre-registered entrants who have complied with the requirements set forth in these contest rules (the "Event") at Century II Expo Hall located at 225 West Douglas, Wichita, KS 67202. One by one in an order to be randomly assigned by Station, each entrant will be required to go on the main stage and walk past a judging table. Once all entrants have been viewed, the contest judges will pick 10 semi-finalists based on any lawful criteria that they deem desirable (including, without limitation, resemblance to Hannah Montana, among other things) and Station will pass out cards to the top ten semi-finalist with specific instructions on where and when to meet in order to compete for the Grand Prize at approximately 2:00pm. **CONTESTANTS SELECTED AS SEMI-FINALISTS WILL BE REQUIRED TO BE PRESENT TO COMPETE FURTHER IN THIS CONTEST FOR THE DURATION OF THE ON-STAGE CONTESTING.** If any top ten semi-finalist does not present themselves within five (5) minutes of the designated time for the final judging, regardless of the reason, Stations reserve the right (in their sole discretion) to disqualify that selected contestant. **SEMI-FINALISTS MUST BE IN AND REMAIN IN THEIR COSTUME DURING THE ON-STAGE CONTESTING.** Station reserves the right to select more than or less than 10 semi-finalists, in its sole discretion.
5. All semi-finalists will be escorted to the stage and will be brought up on stage and walk past a judging table. Once all semi-finalists have been viewed, the contest judges will pick the Grand Prize winner based on any lawful criteria that they deem desirable (including, without limitation, resemblance to Hannah Montana, among other things) subject to verification of eligibility and compliance with these contest rules. The decision of the contest judges will be final and any such decision is not subject to dispute or appeal.
6. Contestants may not violate any federal, state or local laws and must not harm or endanger yourself or other persons or property. Any contestant who Station determines may have created a public hazard, caused interference with or destruction of property and/or utilized public safety resources will be disqualified. The Station reserves the right to eliminate any potential contestant from participation in the Contest for any reason, including, without limitation, for a costume that it deems offensive, indecent or degrading. No costume may impair another guest's view or enjoyment of the event and clothing must fit within the boundary of an individual's ticketed seat location. All costumes and props must comply with venue security regulations and bag/person check procedures. Additionally, toy guns or weapons, costumes with wiring or electrical requirements, live creatures, and nudity will not be permitted. The Station and venue reserves the right to refuse admission to or require leaving the venue by any person whose costume does not comply with these guidelines or poses a danger to other fans. No storage of costumes will be permitted.

8. IN THE EVENT THAT THE EVENT NEEDS TO BE CANCELLED BY STATION DUE TO ANY REASON BEYOND ITS CONTROL OR DUE TO ACTS OF GOD OR WEATHER, THE

STATION RESERVES THE RIGHT TO RESCHEDULE THE EVENT. WHILE STATION WILL ATTEMPT TO CONTACT PRE-REGISTERED ENTRANTS, SEMI-FINALISTS OR FINALISTS (AS APPLICABLE), IT IS THE SOLE RESPONSIBILITY OF EACH ENTRANT TO LISTEN TO THE RADIO STATION FOR ANNOUNCEMENTS OR CHECK ONE OF THE FOLLOWING WEBSITES TO OBTAIN DETAILS ON THE RESCHEDULED EVENT (IF ANY): www.kfhradio.com; www.power939.com; www.keyn.com; www.1053thebuzz.com; www.knssradio.com.

Grand Prize

1. Only one (1) prize will be awarded in this contest.
